FINANCIAL REPORT AND BALANCE SHEET:

TREASURER'S REPORT FOR THE YEAR 1 NOVEMBER 2023 THROUGH 31 OCTOBER 2024

I have the pleasure of presenting my final report as Treasurer of the League, a position that I have enjoyed through some challenging times, both in the League's history, with new systems in place, and in my own personal journey. However, it has been a very rewarding time and I thank all my fellow committee members for their service and commitment over the years and wish the new committee all the very best.

I can confirm that at each Management Meeting during the year, I presented a financial report, detailing all income and expenditure. The records for the year are available for anyone to examine if required.

As per Financial Statement:

Bank Statement Balance as at 1 November 2023 was \$12,068.47 Income for 2024 was \$39,306.50 Expenses totalled\$42,500.10 giving a deficit of\$3,193.60

Income Received:

Annual Fees: 26 member clubs \$ 260, 1069 Associates Affiliation Fees \$ 6414.

League Games: including Entry Fees, Green fees, and lunches \$24,322.50

I have produced an excel document to show the breakdown of all the competitions over the year. This document is available if anyone wants clarification of any of these figures.

22 pennant teams \$176

Income from tournament raffles, after expenses, was \$1496.03

The League has provided raffle prizes for all general meetings and the Presentation lunch 3 x Christmas basket door prizes. Karan Barnes has a \$30 float which she will pass on to the League Management committee for next year's tournaments.

Voucher donations were made by Joan Nicoli (Autumn Cup), Marj Malatesta (Metro Champs) and Shirley Simpson (Spring Carnival Day 1 & 2) totaling \$330. The Financial Statement shows \$60 as an expense, as Marj gives cash on the day, so this is shown to balance that cash payment out.

Expenses:

League Games: including green fees, lunches, refunds, vouchers, prizes, golf balls, engraving, badges & Stripe fees \$31,375.59. Once again we had to pay a room hire fee at Maylands of \$450.

Administrative Expenses:

This year there was no major purchase of any equipment or software. The breakdown of the following costs have been presented and accepted at the appropriate general meetings of the League during the year. These include the ongoing subscription to OneGolf (\$1089). Other normal administration costs include stationery, website maintenance and subscription (\$590 for 3 years), Microsoft 365 annual subscription (\$135) and conducting meetings, the main one being the AGM/Delegates morning tea 2023 of \$587.50 at Royal Perth Golf Club.

Trophy Presentation Luncheon at the MAAC: Cost of the meal this year was \$71 pp, which was an increase on last year's cost. A motion was passed by the Management Committee to subsidize this to the value of \$15 pp, bringing the cost for attendees to \$56. League's expense: \$2374.25 whichcovers life member's lunches (6), subsidy for 89, Tea & Coffee for 79, 3 door prize hampers and room hire charge.

As was the case last year, no honorarium was paid to the Tournament Directors. As the different clubs were running our tournaments, out of pocket expenses can be claimed by either the Tournament Directors or the Clubs incurring any expense.

I would also like to thank Lyndelle Wilson from Hamersley, who stepped forward to be my Shadow Treasurer for the year. We spent this time familiarizing Lyndelle with the spreadsheet, and how the League operates, and she has attended Management Committee meetings as well. In the last couple of months, we conducted detailed budgeting so that a considered recommendation could be presented to Management Committee, giving a report on the running of the Dulcie Liddelow MT, Lucy Greene MT and the Champion of Champions events, which were fully funded by the League.

As you are aware, no extra entry fees or green fees were required to be paid by the Clubs this year for any of these events.

Our total cost for conducting these 3 events on the day was \$1691.00 plus the cost of engraving the badges which is included in the General Expenses for League Games. This is higher than we anticipated, but our numbers were up in all events, which is a great result for all clubs who participated. Green fees were also higher than the previous year. As a result of our recommendation, the League Management Committee voted to increase the Annual Associate Affiliation Fee for 2025 from \$6 to \$7 pp, and not to charge any additional fees for the above competitions. That means that all registered Associates will be eligible to play in the Dulcie Liddelow MT, Lucy Greene MT and the Champion of Champions Playoff competitions in 2025. The change in financing of these competitions has been very helpful to me, as League Treasurer, to our Tournament directors, and for all member club treasurers and secretaries, in reducing workloads and recording around these various playoffs.

This increase in the Associate Affiliation fee is an item in Notified General Business in your Agenda for today's meeting.

The bank statement has been reconciled and the balance as at 31 October, 2024 is \$8,874.87

TOURNAMENT DIRECTOR'S REPORT:

Maryke and I are very glad to have got to the end of another year without too many hiccups – it definitely felt easier than in our first year.

The big thing for us this year was that, as we started to discover last year, a number of clubs have now put limits on the size of the fields they will accept. These are generally council-owned courses run by management companies who are told to ensure general public access at all times – courses such as Marangaroo and Carramar come to mind.

The limit has generally been set at 40 players. It meant that this year we had to run a ninth day of tournaments – rather than eight.

We had to split the Lucy Greene event away from the Champion of Champions and the Dulcie Liddelow event and take the Judy Sinclair away from the 4BBB event.

The Lucy Greene and Judy Sinclair events were then played together at the Embleton course, which seemed to work very well.

We also didn't stage an event at Hamersley this year because of major renovations at that course. It meant that our first four tournaments - Opening Day at Point Walter, the Autumn Cup at Marri Park, the Silver, Brass and Bronze event at Collier and the Metro Championships at Whaleback were all played south of the river, but we definitely plan to be back at Hamersley next year.

Our pennants season this year attracted 22 teams and was played across four divisions. After the season finished a sub-committee was formed to take on-board feedback from clubs about the best way to make the season as competitive as possible. We set out our plan for next year at our previous meeting and will put that into action when we come to organise next year's fixtures.

Our thanks to Robyn Heyting and Pat Fitzsimons who came on board this year to help run the pennants season and to Roberta, who always does a great job getting the results organised.

After the pennants, we journeyed to Hillview for the two-day Spring Carnival, which unfortunately was hit by bad weather on the Monday. The numbers were very similar to last year but this still tends to be the event which attracts the fewest participants.

Then we had back-to-back-back tournaments including the 4BBB playoff, the Judy Sinclair and Lucy Greene events, and then the Dulcie Liddelow and Champion of Champion tournaments. All these events attracted great fields this year – with the League paying the entry fees for the Champion of Champion, Dulcie Liddelow and Lucy Greene events.

We were very grateful to the clubs who assisted us in running these events. It is a great help to us to have people on the registration table, checking lunch orders, starters, getting the novelties organised etc.

Though there are always areas in which to get better, I think we learnt a lot from our first year and Maryke and I again thank all the clubs who did get involved, not only those who hosted a tournament but those from other clubs who offered to help.

Maryke, as you are aware, is stepping down from the role next year and I want to personally thank her for all her hard work and being a great teammate.

In conclusion, we thank everyone for their support this year and wish you and your families a great festive season.

GOLFWA DELEGATES' REPORT TO PSWGL AGM - MONDAY 25 NOVEMBER 2024

Your Delegates have reported to you at the three General meetings of the League which have been held in March, May and October of this year, but the major items from those reports are summarised for this final report for 2024:

GOLFWA

• For PSWGL, the most interesting information to come from our attendance at the GolfWA AGM in March was not only that the fourth female member had been appointed to the GolfWABoard butfollowing that, the Board had elected Emma Elliott, a member of one of our Perth Suburban clubs - the Hamersley Ladies Golf Club as their new Chairperson. Emma had been a member of the Board for several years and is obviously held in high regard by her Board colleagues. We are very pleased to have one of 'our own' holding this respected position. Emma subsequently played in our 2024 District Championship at Maylands in October and also took the opportunity to speak to the assembled players about progress with the transition of the Australian handicapping system from GolfLink to GolfConnect.

• Australian Golf State Services Agreement between GolfWA and Golf Australia

We attended a second GolfWA meeting in June to have this agreement explained by CEO of Golf Australia, James Sutherland and Emma Elliott, GolfWA Chair. The long-awaited agreement will see services for the administration of golf in WA, delivered by the national body to gain additional resources and efficiencies.

GolfWA competitions 2024

GolfWA conducts several competitions to be played in clubs during the year and provides play-off events conducted at various private club courses. Our public course players compete well in these competitions as evidenced by some of the play-off results again this year, competing against ladies from all golf clubs State-wide.

Silver Spoon play-off – an individual nett competition for club winners and played at Nedlands Golf Club on 2 September. Again we had two of our public course players featured with **Diane Bowden of Seabirds** taking third place in the play-off competition for grass greens players and **Sammie Coffey from Point Walter**, who won the May Stillman Cup for the best nett scorein the club competition, for players from all over the State.

Jubilee Fours play-off – played at Joondalup Golf Courseon 3 September amongst winners from clubs from all over the State, **Chis May** and **Alison Bridglandfrom Links** came seventh out of 43 pairs.

GolfWA 4BBB Team Challenge

The play-off was held at Wanneroo Golf Club on 16 September where **Libby Nowlan** and **Marian Aylmore from Yaringa** came 9th in a field of 36 pairs from State-wide clubs.

GOLF AUSTRALIA

• Transition of GolfLink to GolfConnect

There have been a total of six email communications from Golf Australia on this matter since 12 September, with the last one being received last Friday 22 November. Breach of this Rule should be reported to the Tournament Director and could result in a penalty.

Seconded by Shirley Simpson (Whaleback Warriors). Motion was accepted by the meeting.

Ruth Strugnell moved that -

 Motion to accept proposal by Treasurer "To raise the Annual Registration Fee for Associates from \$6 to \$7."

After a detailed review of The League's finances, it was recommended that the Annual Registration Fee for Associates be raised to \$7 to cover increased costs, so the League can continue to finance all our competitions.

Discussion ensued on the wording of this paragraph.

Moved by Margaret Howrie (Sapphires) that Ruth's Motion be amended as follows:

"After a detailed review of the League's finances, it was recommended that the Annual Registration Fee for Associates be raised to \$7 to cover increased costs."

Seconded by Megan Lewis (Point Walter). Amended Motion was accepted by the meeting.

It was recommended to the Delegates that clubs download the relevant forms from the League's website for completion and return to the League. All the relevant forms will be amended as soon as possible and placed on the website for use by the clubs.

GENERAL BUSINESS WITHOUT NOTICE:

• Website Design

The Secretary spoke to the delegates to ask if they were satisfied with the design of the website as the Committee has been considering whether or not the design of the website should be updated for easier use by all concerned. Discussion has taken place between the Secretary and Alison Wakeham, Tournament Director, and it was determined there was no need to redesign the website.

The following questions were asked of the Committee:

1. There is trouble getting the cursor to stay on a selected club under Club Contacts usually the ones at the bottom of the list. It was acknowledged that this can be frustrating for users. Alison Wakeham will investigate to see if changes can be made to make it more efficient.

- 2. A question was asked if Novelties could be included in the results on the website.
- 3. Jil Wilson (Collier) asked if the HISTORY page on the website could be completed. Megan Lewis, who is responsible for undertaking this project, thanked Jil for her question and advised the meeting that she would finalise this in the near future.

• Further Expenses for 2024

A question was asked of the Treasurer if there would be any further expenses before the start of the 2025 season. Ruth advised that the cost of holding the AGM at Royal Perth Golf Club and the morning tea enjoyed at the AGM had yet to be included in the financial report

The cost of the 2 bunches of flowers presented to Ruth Strugnell and Maryke Stockbridge at the AGM were also yet to be included in the financial report.

Change of Bank Signatories

The meeting was asked to approve the change of signatories required due to the retirement of the current Treasurer, Ruth Strugnell, and replaced by the incoming Treasurer, Lyndelle Wilson.

Unanimously approved.

THANKS TO THE MANAGEMENT COMMITTEE:

A vote of thanks to the Management Committee was expressed by the Seabirds delegate, Janine Krause, for the work carried out on behalf of the League clubs during 2024.
